

NIAID's Mission Statement

- NIAID conducts and supports basic and applied research to better understand, treat, and ultimately prevent infectious, immunologic, and allergic diseases.
- NIAID has a unique mandate that requires the Institute to respond to emerging public health threats.
- NIAID's three extramural divisions are the Division of AIDS (DAIDS); Division of Allergy, Immunology, and Transplantation (DAIT); and Division of Microbiology and Infectious Diseases (DMID).





NIAID SBIR/STTR Program at Glance

- Waiver Policy Phase I: \$300K/year for up to 2 years; Phase II: \$1M/year for up to 3 years
 - Topics are interpreted broadly by NIAID Program Officers.
 - Does not impact funding decision (may be reduced if needed)
- NIAID allows Phase IIB applications via the SBIR Parent and select notices of funding opportunity (NOFOs).
 - Matching funds encouraged (not required)
 - SBIR only (Phase II STTR awardees can switch)
- NIAID only accepts SBIR Clinical Trial applications through its U44 mechanism (PAR-24-099).
 - Phase II/IIB, Fast-Track, and Direct-to-Phase II
- NIAID participates in the Commercialization Readiness Pilot (CRP) Program via PAR-23-219 (SB1, Clinical Trials Not Allowed) only.
- NIAID funds applications primarily based on Scientific Merit (i.e., Priority Score).
 - All applications (except CRP, U44) within published paylines are funded.





Technical and Business Assistance (TABA)

- Applicants may request additional funding support for technical and business services:
 - Phase I up to \$6,500 per year
 - Phase II cap of \$50,000 for the life of the project
 - In addition to the amount of the award
- Qualifying services include but not limited to assistance with product sales, intellectual
 property protections, market research and/or validation, development of regulatory
 plans, development of manufacturing plans, and access to technical and business
 literature available through online databases.
- Request this funding within the application in section F. Other Direct Costs, lines 8–10
 on the Small Business Concern (SBC) budget; label the funding as "Technical
 Assistance."
- Include a detailed description of the technical or business assistance that your vendor will provide, including the name of the vendor and the expected benefits and results of the technical or business assistance provided, in the Budget Justification.

- SUBMIT EARLY (days, not hours and minutes)!





NIAID Applicant Assistance Program (AAP) Eligibility Criteria

- The company must be eligible to apply for NIH SBIR/STTR grants based on the NIH Small Business Eligibility Criteria.
- The research area of interest aligns with the mission of NIAID. Read <u>NIAID High-Priority</u> <u>Areas of Interest</u> to help you determine if your application aligns with the mission of NIAID.
- The company intends to submit a Phase I, Phase II/IIB, Fast Track, or Direct-to-Phase II (including U44) SBIR/STTR application. (Completion of the <u>four required</u> <u>registrations</u> is strongly recommended for all applicants.) CRP and Contract applications are not eligible to participate.
- The company intends to submit an application for the **January 5**, **2025**, SBIR/STTR grant submission deadline.
- Phase II applicants must be within the <u>first six receipt dates</u> following the expiration of the Phase I budget period.

NIAID AAP Overview

- The NIAID Small Business Program established an AAP providing SBIR/STTR applicants no-cost training and advising services to increase success for SBIR/STTR applicants.
- This program is intended for eligible NIAID Phase I, Phase II/IIB, Fast-Track, and Direct-to-Phase II applicants.
- This program has an emphasis on engaging and assisting groups underrepresented in extramural biomedical small business programs.

NIAID AAP Structure

- The AAP program has three cycles for the following SBIR/STTR application submission deadlines:
 - September 5, 2024
 - January 6, 2025
 - April 7, 2025
- The first 35 eligible applicants for each cycle are enrolled in the program.

One-on-One Proposal Preparation Assistance

- Assistance Overview
 - Foresight Science & Technology Senior Consultant assigned to each AAP participant
 - Kickoff call with AAP participant: This call will provide initial company assessment (resources, needs, deficiencies); NDA execution (if necessary)
 - Customized Assistance Plan development
 - Customized Assistance Plan implementation



One-on-One Proposal Preparation Assistance

- Customized Assistance Plan Development
 - Initial application assessment, strategic planning, applicant resources, NIHspecific guidance, resubmission guidance
 - A timeline for review of each element of proposal requested by AAP participant, including bio-sketches, budget, research strategy, commercialization plan, and supplementary forms and documents
 - Specifically for Phase I: NIAID resources, topic identification, budget basics, and registration guide
- Customized Assistance Plan Implementation
 - Will offer proposal editing, advising, and reviewing (NOT WRITING) of project content for consistency on each component of the proposal requested by the AAP participant
- Feedback will be provided via iterative reviews with corrections and notes for improvement.

Toolkit Item	Description
Registration Review	Required registrations, sheet for tracking passwords, what to check and when
SBIR/STTR Proposal Checklist (Phase I and II)	Listing of all required sections for a successful SBIR/STTR submission (to ensure no required document is left out of the application package)
Budget Justification Template (Phase I and II)	A template that provides a clear description of what goes under each budget category and the level of detail recommended
Data Management and Sharing Template	NIH requires all applicants planning to generate scientific data to prepare a DMS Plan that describes how the scientific data will be managed and shared.
Excel Template for Budget Planning (Phase I and II)	The template can be used to calculate budget and check distribution of percentages depending on SBIR or STTR (to ensure compliance with guidelines)
Subaward Documents Required/Information Needed Checklist	Review of the process of requesting subaward documents, information that research institutions require, timelines usually required (when to request, when to ask to have them back, etc.)
Specific Aims and Research Plan Template (Phase I and II)	This is an annotated version of the NIH SBIR/STTR Research Plan guidelines.
Phase II Commercialization Plan Template	This is an annotated version of the NIH Phase II Commercialization Plan guidelines.
Letters of Support/Bio-Sketch Templates	Different letter of support templates that include a description of required information for a letter to be "meaningful" in the application
Human Subjects/Clinical Non-Clinical Trial Checklist	If human subjects are involved, certain documents are required. If clinical trials are proposed, there are additional documents required. This checklist will prepare applicants for required documents for both.
ASSIST Cheat Sheet	Quick overview of some common areas of error on the forms and what to select on some tricky questions (new proposal, renewal, etc.)



Before Applying for the AAP

By the time of AAP application, the participant is strongly encouraged to—

- Ensure that the research area of interest aligns with the mission of NIAID
- Have preliminary discussions about the feasibility of Fast-Track and Direct-to-Phase II approaches with the NIAID Program Officer (in the absence of a Phase I SBIR award)
- Initiate (as a minimum) the company registration process
- Assess available resources and background research (particularly, if currently not in Phase I)



Success of AAP

Critical factors for the success of AAP participants include—

- Communication with the Foresight Senior Consultant
- Sticking to the customized Assistance Plan
- Being proactive
- Committing to the submission deadline
